Marina Development Sub Committee

The sub committee members (Trevor Mitchell, Don Drabble, Terry Fitgerald, Kevin Dumbrell, Peter Goode - secretary Janie Dumbrell) have received a quote from SMC Marine for the supply and installation of floating jetty pens to refurbish the pens adjacent to the northern marina wall. The committee are in discussions with SMC to break the quote up into stages of suppply and construction to meet the club budget.

Trevor Mitchell has secured the services/loan of the equipment required to complete the refurbishment of the northern marina wall. Trevor will donate his time as a machine operator to complete the works and has negotiated with local suppliers to supply geotech matting and rocks for the revetment wall at a heavily discounted price. The estimate for the completion of the revetment wall construction is \$120,000.

Motion: The proposed revetment wall project be presented to the members for their consideration and then put to the vote at a special general meeting on Sunday 14th July 2024 at 1:30pm

Motion for a vote at a special general meeting: The members of the Carnarvon Yacht Club Inc agree to the expenditure of club funds up to \$150,000 to refurbish the northern marina wall as a revetment style wall similar to the south and eastern marina walls.

action: secretary to post a notice in the club rooms and email all members notifying them of the special general meeting and the reason for the meeting in accordance with the club constitution.

General Business

- Carnar-Fin Another successful event, well attended despite the inclement weather toward the end of the week.
 Sean Challis has asked CYC if a relocation of the gantry support is possible. The committee agreed to the relocation paralell to the flag poles.
- Venue hire and Events Alicia briefed the committee on upcoming events. The club has secured the closing ceremony event for NAIDOC week. An events props budget of \$700 has been requested to purchase tablecloths and decorative lights.

Motion: A budget of up to \$700 be allocated to events props and that budget be managed by club events coordinator Alicia Zwart.

- The entry gate repairs are complete and payment has been made. Mick Torossi voluteered to replace the entry
 overhead glazing and clean the mens clubhouse ablutions. New swing door hinges have been ordered for the
 kitchen swing door.
- Real futures has donated a trophy to the value of \$200 for Windrush 14's State Titles.
- Ray Ellis has offered to refurbish the firebug fleet with a budget of \$1000.

Motion: Funds up to \$1000 be available to Ray Ellis to refurbish the Firebug Fleet.

- Two tandom trailers will be required to transfer the windrush fleet to Bush Bay for the downwind event each year. John Rodier to explore opportunities to procure these with estimate costings.
- The Exmouth sailing club has agreed to the CYC taking possession of the remaining windrush fleet based at the Exmouth Yacht Club. John Rodier will organise retrieval of the vessels. He is asking for the cost of his fuel to be reimbursed.

Motion: The fuel costs incurred when retrieving the gifted windrush 14 vessels from Exmouth be reimbursed to those members involved.
